Essential : (i) Degree from a recognized University or equivalent (ii) Five years experience in Administration/Accounts

Eligibility for deputation : Officers under Central/State Government/ Universities/
Recognized Research Institutes/ Public Sector Undertaking/Semi Government/Autonomous/Statutory
Organization.

(a) (i) Holding analogous posts on regular basis, or (ii) Officer holding regular posts in the grade pay scale of Rs. 4000-6000 (Pre-revised) with ten years regular service.

(b) Possessing qualification prescribed for Direct Requirement.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization of department shall not ordinarily exceed three years) the maximum age limit for transfer on deputation shall not be exceeding 56 years as on the closing date of receipt of application.
