CIRCULAR

Sub.: Assessment of Training Programmes in Disability Rehabilitation and Special Education:-reg.

In continuation of the Council's circular of even number dated 19.07.2022, it has been found that visiting experts which are deputed for assessment of institutions for granting permission to run RCI course, are not conducting the inspection in 14 days of stipulated time. This has been viewed seriously and following instructions are issued for information of all visiting experts:

1. The responsibility of conducting inspection within 14 days time lies with the host institution and the deputed visiting experts. Therefore, it is required to conduct it within stipulated time of 14 days. Even if the institute expresses unwillingness/ non-readiness for inspection, the inspection shall be jointly conducted by experts and reported accordingly to finalise the recognition case by RCI, as deemed fit.
2. Institute shall ensure readiness all the time after applying to RCI for inspection.
3. The joint inspection report must reach the Council by email (original scanned copy at email ID: adprci-depwd@gov.in only) and speed post, both, within 5 days after conducting the inspection.
4. If the visiting expert(s) deny or take time more than stipulated 14 days period in conducting inspection from the date of issuance of inspection letter, same shall be informed to RCI on above email indicting reasonable grounds/emergencies, however, under any circumstances, only for a maximum of one time such delay beyond 14 days (but not exceeding another 15 days) shall be considered by RCI in a calendar year, failing which, the name of expert shall be delisted from the panel of experts of RCI for 2 years.
5. Since it is a pre-decided/informed inspection, the responsibility of carrying out inspection lies jointly with inspectors and institution. Any excuse/ reason causing delay in inspection shall be taken adversely accordingly and all are advised to honour the timelines above meticulously.

CIRCULAR

Sub.: Assessment of Training Programmes in Disability Rehabilitation and Special Education:-reg.

The Council has issued assessment orders to conduct assessment of all eligible proposals for the academic session 2021-22 & 2022-23. It has been observed that the assessment of training institutions sometimes get delayed due to either pre-occupation of visiting experts or refusal by them or any other prevailing situation due to COVID-19 pandemic, which affects the decision of the Council with regard to training programme. This has been viewed seriously by the Council and the Council in its 85th meeting of EC has decided that if the visiting expert refuses to conduct assessment twice in an academic year for conducting assessment, name of such visiting expert will be deleted from the panel of visiting experts for the next one year.

In view of the above, it is advised that the assessment to be completed by the deputed team of visiting experts within two weeks of issuance of assessment orders.
