
- D.Ed.Spl.Edu. -Mental Retardation

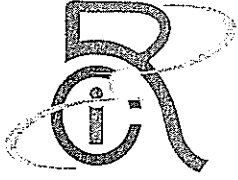
