
Sir/Madam,

2. Further, you are requested to develop the content for Pedagogy of Teaching Language such as Tamil, Kannada, Punjabi etc. A suggestive line of content has been provided in the syllabus for Hindi and English; please adopt all these as per the BOS and your state's requirement.
3. Practicum is an essential part of these courses; please do ensure adequate arrangements in the time table as well as with schools and field to prepare good teachers/ educators for special education.
4. Though each paper has been provided with Lists of Essential and Desired Readings; you may need to work further on these. Essential implies such books that will cover maximum of the course and is available to students in the Library and/ or online/ internet etc.
5. You may share the references of books available in the regional languages with the Council that can be uploaded on RCI's Portal of Punarbhava.
