It was informed to the Screening Committee that an advertisement was issued and published in the Employment News dated 9-15 January, 2016 calling for applications to the post of Deputy Director (Admn.), RCI on deputation basis, after approval of Secretary, DEPwD & Chairperson, RCI. The last date for receipt of application was given as 23.02.2016 (45 days from the date of publication of advertisement in Employment News). 
Following are the details and requirement of the post as advertisement in the Employment News:

1. Name of Post : Deputy Director (Admn.) – Group 'A', Ministerial
2. Method of Recruitment : on Deputation
3. No. of Vacancy : One
4. Scale of Pay : PB-3, Rs. 15600-39100 + GP Rs.6600/-
5. Eligibility Criteria : Officers under Central/State Government/Universities/Recognised Research Institutes/Public Sector Undertakings/Semi Government/Autonomous/Statutory Organization having:
 - (i) Analogous posts on regular basis, or
 - (ii) Posts in PB-2, Rs.9300-34800 plus Grade Pay of Rs.4600/- with eight years regular service in the grade (Pre-revised pay scale of Rs.6500-10500).
 - (iii) Degree from a recognised University or its equivalent.
