In this context, the Council has received requests/representations from many quarters for extension of last date for admission to RCI approved diploma and certificate courses due to non declaration of result of XII Std by many States / UT's.

As such the Council has decided to extend and revise the schedule of admission for all diploma/certificate level courses for the academic session 2016-17 as follows :

- Admission Lists received after 30th June, 2016 will not be considered.
- The classes will commence from 4th July, 2016.
- Vacant seats if any, shall be first filled up by wait listed candidates by 1st July, 2016 positively, under intimation to the Council.
- After 1st July, 2016, no vacant seats shall be filled without prior permission of the Council.

The first list of admitted students should be submitted to the Council in the prescribed format through email(nber@rehabcouncilindia.org) by 25th June, 2016 and by post latest by 30th June, 2016 and list of students admitted from wait list shall be submitted to the Council by 1st July, 2016 by E-Mail and by 7th July, 2016 through post. This schedule should be strictly adhered to by all concerned institutions/organizations. List of admitted students received after due date will not be entertained.

Further, new institutions receiving approval to offer RCI approved Certificate/Diploma programmes for academic session 2016-17 are directed to complete all formalities of admission within one month from the date of issue of Certificate of Approval by the Council. The institutions will be responsible for prescribed curriculum transaction and the same should be intimated to the Council.

Remaining instructions regarding admission shall remain same as given in the earlier circular dated 04.04.2016 in this regard.
