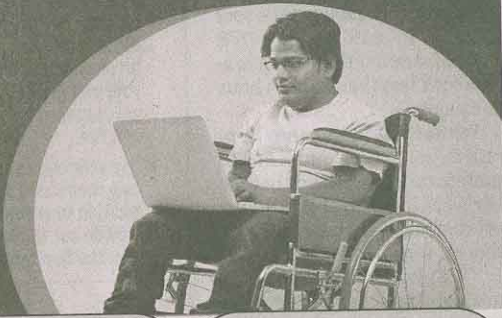

Invitation for online proposals for permission to conduct RCI's approved training courses in the field of Disability Rehabilitation & Special Education for the Academic Session 2015-16

Rehabilitation Council of India (RCI) invites ONLINE PROPOSALS for grant of approval to conduct RCI's training courses in the field of Disability Rehabilitation and Special Education through regular mode for the academic session 2015-16 from Govt. Institutes / Universities / Registered NGOs / Medical Colleges / Institutes. For details of approved training courses, eligibility conditions, format of application and required infrastructure etc., log on to RCI's website www.rehabcouncil.nic.in

Fresh proposals for permission to conduct RCI's approved training courses:

Institutes fulfilling the prescribed eligibility conditions may submit their **ONLINE PROPOSAL(s)** latest by 31st August, 2014 along with all the required scanned documents and processing fee of Rs. 7500/- in the form of Demand Draft separately for each training course, favouring 'Rehabilitation Council of India', payable at New Delhi. After submission of the online proposal, the Institutes should submit (i) printout of the e-mail containing automatically generated proposal ID, (ii) copy of NOC from the respective State Govt. and (iii) Demand Draft of Rs.7500/- as processing fees. Proposal(s) received without the above said documents mentioned at sl.no. (i) to (iii) will be rejected summarily. Online registration window will be open from the date of Advertisement to **31st August 2014 upto 5.30 pm.**

Extension of Approval for permission to continue RCI's approved training courses:

Existing RCI's approved institutes desirous to continue their ongoing courses from the academic session 2015-16 may also submit their **ONLINE PROPOSAL(s)** latest by 31st August, 2014 along with all the required scanned documents, processing fee of Rs.7500/- and inspection fees of Rs.15,000/- for certificate / diploma; Rs.22,500/- for Degree / P.G.Diploma & Rs.30,000/-for Master & above level courses in the form of Demand Draft separately for each training course, favouring 'Rehabilitation Council of India', payable at New Delhi. Proposal(s) without the prescribed fees will not be considered by the Council under any circumstances.

LAST DATE FOR SUBMISSION OF ONLINE PROPOSAL(s) for FRESH / EXTENSION is **31st August, 2014 upto 5.30 pm.**

No proposal(s) (Fresh or Extension) will be entertained after the due date.

NOC is mandatory for each fresh proposal.

Please note that proposal(s) without NOC will be rejected by the Council.

Note: Under Section 11 of the Rehabilitation Council of India Act, 1992 and under Section 24 of RCI Regulations, 1997, it is mandatory to obtain prior approval for running any RCI approved Courses. Under Section 13 of the RCI Act, 1992, "No person other than the rehabilitation professional who possesses a recognized rehabilitation qualification and is enrolled on the Central Rehabilitation Register, shall practice as a rehabilitation professional anywhere in India"
